Essential firefighter duties: Equipment placement, lay and connect hoses, operate high-capacity pumps and direct water streams, raise and climb ladders, use chemical extinguishers, safety belts, lines and hook and self-breathing apparatus. Other firefighter responsibilities: enter burning buildings as part of fire suppression team, perform ventilation tasks above ground, carry heavy equipment, and rescue injured or trapped victims. Emergency Medical Technician duties: respond to requests for pre-hospital emergency medical care and transport of sick or injured persons, set up and operation of oxygen and auto-defibrillation equipment, administer pre-hospital emergency medical care to the sick and injured, and keep firefighters current with proper traffic incident management response.

1995 – 2009 Rutgers Police Department, Rutgers University, New Brunswick, NJ

- **Sergeant/Emergency Medical Technician**
Supervised numerous investigations of alcohol and drug incidents including the “Check for 21” and “Cops in Shops” enforcement programs. Created operation plans for short- and long-term events for 10 to 70,000 persons. Plans for large scale events included personnel assignments, external stadium/building enforcement, stadium medical response coordination, internal stadium/building command, traffic control in accordance with MUTCD, and evacuation plans.
- **Police Officer/Emergency Medical Technician**
Key member of the Law Enforcement and Community Police Units providing community services such as the arrest of alcohol and drug law violators and undercover and uniformed regulatory investigation involving alcohol enforcement. Over 1,000 investigations covered: the sale or possession of alcohol to underage persons, the sale or possession of alcohol to intoxicated persons, the sale or possession of alcohol to drugged persons, and field testing and arrest of intoxicated drivers. Provided trial testimony for civil and criminal investigations. Offered instruction on identifying signs of intoxication, explanation of local and state laws, establishment safety, fake/false identification, refusal of service, and conflict resolution.
